### The Single Sign-On Solution:

A Hot Topic webinar series was delivered on the Florida Department of Education's Single Sign-On Solution (FLDOE SSO) in July and August 2012. The webinar shared some key points for Local Education Agencies to know at this time (LEA, i.e., school district, college, university, etc.). Here are a few of the highlights:

- FLDOE's SSO Solution is standards-based and flexible to leverage LEA's existing investments in technology.
- Acces to FLDOE Applications will be from one web address www.fldoe.org/SSO
- Only one username and password will be needed for access to up to six FLDOE applications:
  - CPALMS Statewide Standards and Instructional Resource Tool
  - eIPEP Educator Preparation Institution Reporting Tool
  - English Language Arts Formative Assessment
  - FloridaSchoolLeaders.org Leadership Development Tool
  - Interim Assessment Item Bank Test Platform
  - PMRN Interim Assessment for Reading
- All LEAs must provision (create, update, and disable) accounts in FLDOE's SSO for all users in their organization, including from charter schools.
- LEAs have choices!
  - Minimally, LEAs may choose FLDOE Hosted Accounts. Users would receive a username/password from the FLDOE SSO.
  - Optionally, LEAs may choose to establish a WS-Federation (SAML 2.0) with the FLDOE SSO. Users access FLDOE applications with the username/password issued by their LEA.
