Upcoming Hot Topic Webinars

Hot Topic Webinars regarding the on-boarding process are scheduled for early April. There are three sessions to choose from. Each session will cover the same topics: the LEA on-boarding process, selecting an authentication option, provisioning file information, and the timeline. Selecting an Authentication Option

One of the most important decisions to make before implementing FLDOE SSO is selecting the LEA's authentication method. There are two choices: FLDOE-Hosted or WS-Federation.

- **FLDOE-Hosted:** The FLDOE-Hosted option is the most basic option to implement. It requires LEAs to send user provisioning information to FLDOE (via files or the web). With this information, FLDOE will issue a username and send an email to the user to complete the account registration process. With this method, when users are ready to use FLDOE resources, they will navigate to FLDOE to log in.
- **WS-Federation:** The WS-Federation is more of a true single sign-on experience for users. It requires LEAs to send user provisioning information to FLDOE (via files or the web), maintain current SAML 2.0 compliant federation service, an SSL certificate, and a code signing certificate. Users will authenticate with the same username and password they currently use to access school district resources. Therefore, with this method, users must log in to the school district network first before accessing FLDOE resources.

Both options, including the pros and cons of each, will be discussed during the April webinar series. Additionally, a short video called *Making a Choice* is available at www.fldoe.org/sso/communications/asp.
